



2017-18 APPLICATION FOR SPECIAL TUITION GRANT
FOR CATHOLIC SCHOOL TEACHERS & PRINCIPALS
IN THE ARCHDIOCESE OF SEATTLE

ELIGIBILITY REQUIREMENTS

Who is eligible? Full-time religious lay teachers and principals of Catholic schools under the auspices of the Archdiocese of Seattle may apply for the grant provided they are matriculated in an eligible graduate degree program in the College of Education at Seattle University.

Which degree programs are eligible? Individuals must be matriculated in a graduate degree program in the College of Education. This does not include 1) the MIT or Doctoral programs and 2) non-matriculated students.

How much will I have to pay? Grant recipients pay half of regular tuition for eligible graduate Education courses; the grant covers the other half. Tuition for 2017-18 is \$619 per credit beginning Summer Quarter 2017 and ending Spring Quarter 2018. Your half is \$309.50 per credit.

THE APPLICATION PROCEDURE

- 1. Apply for regular admission to Seattle University, School of Education at least six weeks before classes begin. Transitional admission does not count.
2. If you want to be considered for other financial aid, please submit a 2017-18 Free Application for Federal Student Aid (FAFSA) by going to www.fafsa.gov as soon as possible.
3. Submit this form to Student Financial Services. Submit only one form for 2017-18 (Summer 2017, Fall 2017, Winter 2018 and/or Spring 2018).
4. Register for your class(es).
5. Pay your part of the tuition by the due date each term. That date is listed in the quarterly class schedule.

RESTRICTIONS

- Seattle University reserves the right to limit the number of Tuition Grant recipients in any particular course or program. Students are admitted on a "space available" basis.
This grant is not retroactive. You will not be given a grant for courses taken before you matriculated into an eligible program nor for courses taken when you did not apply for or were not eligible for a grant.
