Research Interests

My major research lies primarily in the philosophy of Martin Heidegger and its import both as a dialogical method and a site of creative expression to the extent that this helps to explore the philosophical foundations of language and its effects on religious and political dialogue. More specifically, I am interested in the problem of "language" and why neither structuralist nor expressive models of language succeed. Heidegger's later work, 1949-76, has been the concentration of my dissertation on language as way-making that argues for a different model than the expressivist or designative schools of language.

Corollary questions arise-What is the fundamental nature of language? What role does it play in the structure and functioning of the "world"? What is its relation to the human person and what this implies for the cultural, ethical and religious dimensions of human life? These questions lead to the problems of self and subjectivity and conceptual formation. Heidegger's early work in the 1920s exhibits a phenomenological approach that reworks many historic philosophers and their ideas of the person and the way concepts are formed. Tracing Heidegger works in this phenomenological period yields valuable insights on the human person and conceptual formation. A number of articles emerged, and eventually a book will arise from this scholarship.

Joining this recent scholarship of Heidegger's early works and the scholarship on the dissertation with a third set of research now underway on the controversial middle period of Heidegger's political writing, 1930-49. This period of fractured language will help to portray a fuller picture of Heidegger's conception of language.

These three areas will enable a comprehensive argument of Heidegger's idea that language is transformed in three stages, yet nevertheless language remains consistent. Language for Heidegger is seen as the abandonment of Being, broken and dispersed, unfolding back to its source as the way for the future. In other words, language is the way of life in all its manifestations, but primarily as a way of engaging with that we cannot see, understand or explain; namely, Being. From this research a book will expand upon the dissertation by including all three periods of Heidegger's oeuvre.
