


# THREE YEAR COMPARISON OF FUNDS RECEIVED BY **COLLEGE/DIVISION**

# **Creating your Research Roadmap**

Developing your grant portfolio takes time and strategic planning. The OSP assists faculty with creating a unique "research roadmap" based on your discipline, scholarship goals, and the funding landscape. Our Sponsored Research Officers work individually with you to identify grant opportunities to strive for, which build upon one another, to grow your scholarship and achieve your goals.

No one path is alike-as seen in Dr. Dale and Dr. Von Esch's experiences in growing their grant portfolios through a planned approach-though you'll notice similar characteristics that lead to funding success.



Over the past five years at Seattle University, I have secured three external grants in support of my research, which broadly focuses on diverse forms of philanthropy. When I began at Seattle U, I was a subawardee on a multi-million dollar grant from the Bill & Melinda Gates Foundation to Indiana University to commission new research on women's philanthropic giving. Being part of that first award gave me the experience and confidence to submit proposals to The Giving USA Foundation in 2018 and to the Ford Foundation in 2019 in response to specific RFPs, both of which I was later awarded and served as principal investigator. Due to the scale of both projects, receiving external funding has allowed me to hire SU graduate students, receive several course releases and funded summer salary. In addition, these projects have been integral to building my scholarly profile with a combination of academic and practitioner publications as well as conference presentations around the world.

## Elizabeth Dale, Assistant Professor, College of Arts and Sciences



My research focuses on how teachers learn to work with their culturally, linguistically, and racially diverse students in K-12 classrooms through joband classroom-embedded professional learning opportunities. As a novice grantseeker and with support from Sarah Bricknell and OSP, building upon my scholarship funded by internal grants, I took a two-pronged approach to seeking external funding: (1) starting with solo small foundation and organizational grants (in addition to internal Seattle University funding); and (2) building experience in seeking out larger grants by being an NSF reviewer and applying to the McDonnell Foundation in partnership with colleagues from other institutions. I have been successful both in securing small grants from organizations such as TESOL and larger grants such as from the James S. McDonnell Foundation in partnership with colleagues at the University of Washington.

# GROWTH

At the start of AY20, the OSP was prepared and ready to turn a new leaf for sponsored projects at SU. Fully staffed, a calendar of events and new offices in Hunthausen 120, we were ready to promote, assist, and support our community in pursuit of external funding. And in the first two quarters, we were able to implement our plan. We hosted 5 campus-wide events with 141 in attendance, met with faculty in individual consultations and supported 36 proposals submissions. The trajectory for all of our metrics indicated a year of great growth.

Then, COVID struck. We worked with our Principal Investigators to adapt their projects, budgets and timelines to this new environment. As faculty worked diligently to move classes online, we wondered if they would they have the capacity to continue to pursue external funding. Very quickly we realized that while everything else was in flux, faculty were still eager and able to engage with OSP. The result? 45 proposal submissions in the second half of the year versus 36 in the first half, with 21% of all submissions coming from first-time submitters. One-on-one consultations also increased with faculty requesting to meet about their funding roadmap or a specific opportunity, with 71 consultations in the first half growing to 85 in the second half of the year.

With your partnership and collaboration, we look forward to building on this growth in AY2021. As seen in Dr. Dale and Dr. Von Esch's research roadmaps (on page 6), we know that leveraging subawards and internal seed funding to build upon research and seek external funding is a successful strategy. In the past 5 years, 43% of the Summer Faculty Fellows went on to request external funding (at a 38% success rate). We hope to grow this trend with other internal grant recipients, and all of our community members, by developing your own research roadmap and grantsmanship skills.

Keep an eye out for funding opportunities and upcoming events in our quarterly newsletter, the OSP Observer, and on our website. While modifying our offerings to an online format, we're preparing to host research- and proposal-focused learning opportunities, celebrations of scholarship and create synergistic spaces that bring faculty and staff together to learn and connect. We're ready to work with all faculty and staff who are ready to grow-soar-with us.
