LOCATION

Seattle, a bustling metropolis, is located in the beautiful Northwest, an area known for its pristine natural beauty and abundant recreation. COURSES

Subject Courses:

Most courses are taught in English. Students can select from a variety of courses in the **1000-4000 level range**. [Courses from the School of Law, Graduate courses, and certain Undergraduate Programs (Humanities, Interdisciplinary Liberal Studies, Forensic Science, Design, Diagnostic Ultrasound, Nursing, and University Honors) are **not available** to Exchange students.]

Language requirement:

English proficiency is required. Most courses are offered in English, but an English Language Learning Center is offered to prepare non-native speakers of English for a productive academic career at Seattle University. Non-native English speakers are required to submit proof of English proficiency through TOEFL scores. Min/Max number of credits:

ACCOMMODATIONS

Type of student housing available & cost estimate:

Exchange Students are required to stay in On-Campus housing. Residence hall housing options include single, double, triple rooms, apartment style living, and intentional living communities. Prices vary greatly according to housing options and amenities. See http://www.seattleu.edu/housing/ for more details.

Food cost estimate:

All students living in residence halls are required to choose a meal plan. Freshman and sophomores are required to have at least the Residential Meal Plan option (\$2,000/quarter) when living on-campus.

COST ESTIMATES

Tuition:

Students' tuition costs are covered under the Reciprocal Exchange Agreement between Seattle University and the home institution. Students are responsible for covering all other costs, including SU fees (technology fee, recreational fee & orientation fee(s)), food, housing, books and personal expenses.

Average cost of living per Quarter:

Food, housing, SU Fees, books, insurance, local transportation, etc. is approximately \$5,000 - \$9,000 but varies depending on housing option, meal plan, personal spending, etc.

HEALTH INSURANCE & FREQUENTLY ASKED QUESTIONS

VISA & RESIDENCE PERMIT

International students are required to obtain a J-1 visa to study at Seattle University. After submitting the exchange application, students will be assigned a SEVIS ID number. This information will be included in the student's admissions email. Students can then make an appointment with the US Embassy (www.usembassy.gov) and pay the SEVIS fee (www.fmjfee.com). Students must present proof of SEVIS payment during their visa interview.

The waiting time for an interview appointment for applicants can vary, so students are strongly encouraged to schedule their interview appointment as soon as they receive their acceptance packet from Seattle University.

Are international students allowed to work?

Students on a J-1 visa are permitted to work up to 20 hours **on campus** when enrolled as a full-time student. Students who wish to work off-campus must obtain express permission from the International Student Center and/or the Bureau of Citizenship and Immigration Services.
